**Peewee Race is Saturday, September 23rd, 2017**

**\$50.00 ADDED MONEY and Prizes to Top 3 in Each Division of the Unassisted Divisions.**

**\$25.00 ADDED MONEY and Prizes to the top 3 contestants in the Assisted Costume Contest (no divisions).**

Participation awards to all pre-entered contestants!!

**Unassisted Rules:**

Age limit is 8 & Under (as of January 1, 2017). One race will be run for all of the peewee UNASSISTED RIDERS. Awards will be given in the Unassisted Riders Division for the "Best Dressed Award." This race will be a 3D divisional race. We will award prizes and payback to the top 3 contestants in each division and all contestants will receive participation awards. The show staff reserves the right to decide how many seconds will be in each division of the unassisted bracket once the race is complete to allow a fair and fun environment for the children. This is solely to be able to include the majority of the children in the awards and payback. The peewee race will be run on a smaller pattern. This event is for the children—so let's keep it that way! Entry fee is \$10.00 with 100% payback.

**Costume Contest for Assisted Rider Rules**

Age limit is 8 & Under (as of January 1, 2017). The Assisted Rider competition will be a COSTUME CONTEST and not a timed event. Contestants in this event must be assisted on a lead-line. The assisted riders cannot compete in the Unassisted competition nor may an unassisted rider compete in the costume contest. There will be three top awards for the costume contest winners. Contestants will enter the arena as directed in the order of their draw numbers posted in the program.

**Contestants who enter the PeeWee events may not enter any other event during the Kansas NBHA State Championships.**  
**Peewee's are required to follow coggins and check-in rules.**

**\$5.00 Late Fee after September 6<sup>th</sup> 2017.**

Entries are limited to one horse entered per contestant. Contestants are not required to be an NBHA member.

Contestant knows and agrees that by his or her signature on this form, he or she completely releases the **NBHA** and its directors, officers, representatives, employees and agents for any liability, including negligence. Contestant voluntarily chooses to participate in **NBHA** sanctioned events and barrel races and freely and willingly consents to same. Contestant further acknowledges that he or she has no absolute property or other right to participate in **NBHA** events.
